**CONDITIONS OF HIRE**  
**OFF ROAD CAMPER TRAILERS**  
**Please read carefully before signing**

I (Name) \_\_\_\_\_ AGREE with and have initialed each of the following conditions.

That the *camper trailer* is currently clean and in good working order. \_\_\_\_

To return the *camper trailer* by the due date and time. \_\_\_\_

That the *camper trailer* will be returned clean and in good working order. \_\_\_\_

To keep tyres suitably inflated and if any tyre is damaged I will pay the replacement cost of the tyre or puncture repair. (70% tread) \_\_\_\_

To not overload the camper trailer beyond its limits (500kg). \_\_\_\_

I will reimburse *Kimberley Camping Hire* for any damage to the camper trailer caused by any water damage due to submersion. \_\_\_\_

I will reimburse *Kimberley Camping Hire* for any damage to canvas, zips, windows, floor, poles, pull out kitchen and any standard accessories hired with the trailer i.e. stove, gas bottle, water containers, mattresses, storage bins. \_\_\_\_

I will notify *Kimberley Camping Hire* of any developing fault or damage in the *camper trailer* and will not tow the trailer if it becomes unsafe. \_\_\_\_

I will ensure the *camper trailer* is used with care and due consideration for other persons. I agree any reckless use of the camper trailer will result in the termination of this agreement and will tender our insurance null and void. \_\_\_\_

I will comply with all relevant laws, regulations, rules and bylaws regarding the use of the *off road camper trailer* and pay any fees and charges incurred.(Including Road Closures, as driving on these may void any insurance) \_\_\_\_

That if I wish to return the camper trailer prior to the appointed drop off date I must give 3 days (7 days in school holidays, all states) notice to receive a refund \_\_\_\_

I will pay a **BOND of \$500** and it will be held for **up to 7 days** after the drop off of the *camper trailer*. \_\_\_\_

I am agreeing to the use of my credit card to pay any additional charges in the event that the insurance cover is void. \_\_\_\_

I UNDERSTAND and have initialed each of the following conditions

I will be responsible for all damage and injury, risk and liabilities:-

- To the camper trailer or caused by the camper trailer.
- To any person caused by the camper trailer.
- To any property caused by the camper trailer.

Arising under this agreement. \_\_\_\_

The *camper trailer* is covered by insurance for theft of and damage to the **camper trailer** as long as I have adhered to the conditions above. The **excess** being the \$500 bond paid. \_\_\_\_

If the camper trailer is hired only one way and freight service is offered, the hirer is responsible for the camper trailer until its return to Kimberley Camping Hire in Broome. \_\_\_\_

**A minimum cleaning fee of \$50.00 per hour** will be charged if the *camper trailer* is not clean at the time of check in \_\_\_\_

If the **camper trailer** is not returned on the due date a daily rate of \$135.00 will be charged. \_\_\_\_
